



Privacy Statement regarding the General Data Protection Regulation (GDPR)

1. Identity of the company;
 - Seabed BV, Asterweg 117, 1031 HM, Amsterdam, The Netherlands, CoC 34202801
 - Seabed trades and assembles products for business clients (not for consumers or private persons)
2. Contact details Seabed;

3. Seabed collects and stores contact details of persons employed by (or associated with) its business partners (e.g. customers and suppliers). These data consist of names, (business) phone numbers and email addresses only. If you are (or were) employed with a Seabed business partner and your contact details are known to us, you are most likely aware of this. If you are not sure if Seabed has collected and stored your personal data and would like to verify this, please contact us on above email address.
4. Seabed only collects and stores contact details of its business partners with the purpose of:
 - i. doing business (commercial) transactions,
 - ii. being able to provide support (technical instructions, repairs etc.) for supplied products, or
 - iii. maintain contacts with its business partners by phone, company visits or network events.
5. Seabed stores and processes contact details in its ERP system and address lists of its email programme.
6. The Seabed website, sales@seabed.nl, does not use 'cookies' nor does it collect in any other ways personal data (e.g. IP addresses).
7. The recipients and users of personal data are:
 - a. Seabed staff working in purchase, sales, support and administration
 - b. Seabed uses courier delivery for shipment of its products to customers. Therefore, in some cases, contact data (names) will be provided to couriers.



8. For how long will your contact details be kept?
 - a. Seabed stores contact details of business partners for a maximum of 7 years after the last business transaction.
 - b. Seabed immediately deletes contact details at the request of the person in question or its business partner, for example in case a person is no longer employed by that business partner.
9. What rights do you have as a person?
 - a. Persons have the right to view their contact details with Seabed and have them adjusted or deleted. You can issue a request at sales@seabed.nl.
10. You can object to the processing of personal data by Seabed;
 - a. Persons have the right to object to the collection, storing and processing of their personal data by Seabed. You also have the right to withdraw a previously issued authorisation for collecting your personal details.
11. You have the right to complain with the relevant authorities:
 - a. If a person suspects that Seabed is inappropriately collecting, processing or storing personal data, they have the right to file a complaint with Autoriteit Persoonsgegevens in The Netherlands, or any other relevant EU Authority.
12. Supplying personal data to Seabed is no legal obligation. Neither are there any contractual obligations or conditions for the execution of a transaction where you, as a person, are obliged to provide your personal details.
13. Seabed does not make use of automated decision making or profiling.
